#### **Explanatory Note**

Attached as Exhibit 99.1 is the form of an updated slide show that Gerdau S.A. (the Company ) and its subsidiaries Gerdau Ameristeel Corporation ( Ameristeel ) and Gerdau Macsteel, Inc. ( Macsteel ) intend to use in presentations made to the employees of Ameristeel and Macsteel regarding an anticipated one-time voluntary stock option and stock appreciation right ( SAR ) exchange program for eligible employees (the Exchange Program ).
