- (1) The purpose of this amendment is to correct the explanation in this footnote (1). Table I securities acquired properly reflect the grant of restricted shares which vest in seven installments commencing March 15, 2008 and continuing on each January 15 until January 15, 2014. Shares of phantom stock were acquired under the Brandywine Realty Trust Executive Deferred Compensation Plan and are payable in common shares as elected by the reporting person pursuant to the Plan which may include such dates as termination of the reporting person's employment with the issuer or upon reaching a specific age and such shares are exempt from 16(b) pursuant to Rule 16b-3(d). The reporting person's account was credited with phantom stock at a rate of \$29.9115 per unit on February 09, 2007 on account of bonus deferral. Each phantom share has the equivalency of one common share.
