- On December 1, 2011, Sunoco, Inc. ("Sunoco") announced that its Board of Directors had declared a special stock dividend of the 56,660,000 shares of common stock, par value \$0.01 per share (the "Common Stock"), of SunCoke Energy, Inc. (the "Company") owned (1) by Sunoco to Sunoco stockholders of record as of the close of business on January 5, 2012. The distribution of the special stock dividend was made on January 17, 2012 (the "Distribution Date"). Effective as of the Distribution Date, Sunoco is no longer a controlling stockholder of the Company and ceased to own any shares of the Company's Common Stock.
