An additional one-half of the original grant vests on April 27, 2008, subject to the Company's attainment of preestablished financial performance goals. In connection with the Separation Plan, vesting was accelerated to August 15, 2006. In addition, 22,441 Performance-Vesting Restricted Stock Units, which were to originally vest upon the attainment of above-target performance goals, terminated as disclosed in Cendant's Current Reports on Form 8-K dated March 27, 2006 and October 27, 2005.

- (4) One-half of the original grant vests in four equal installments on April 27, 2005, 2006, 2007 and 2008, subject to the Company's attainment of preestablished financial performance goals. An additional one-half of the original grant vests on April 27, 2008, subject to the Company's attainment of preestablished financial performance goals. In connection with the Separation Plan, vesting was accelerated to August 15, 2006. In addition, 24,962 Performance-Vesting Restricted Stock Units, which were to originally vest upon the attainment of above-target performance goals, terminated as disclosed in Cendant's Current Reports on Form 8-K dated March 27, 2006 and October 27, 2005.
