Item 4.01 Changes In Registrant's Certifying Accountant

On August 20, 2009, Kentucky First Federal Bancorp (the "Registrant") formally notified BKD, LLP ("BKD") that BKD would not be retained as the Registrant's independent registered public accounting firm for the fiscal year ending June 30, 2010. However, BKD was engaged to audit the Registrant's consolidated financial statements for the fiscal year ended June 30, 2009, and, in fact, issued their audit opinion on the Registrant's consolidated financial statements on September 28, 2009.

BKD's reports on the Registrant's financial statements for the fiscal years ended June 30, 2009 and 2008 did not contain an adverse opinion or disclaimer of opinion and were not qualified or modified as to uncertainty, audit scope, or accounting principles. During the Registrant's two most recent fiscal year ends (the fiscal years ended June 30, 2009 and 2008) and through September 28, 2009, there were no disagreements with BKD on any matter of accounting principles or practices, financial statement disclosure, or auditing scope or procedure, which disagreements, if not resolved to the satisfaction of BKD, would have caused BKD to make reference to the subject matter of the disagreements in their reports on the financial statements for such years. BKD has provided the Registrant with a copy of BKD's letter addressed to the Securities and Exchange Commission stating that BKD agrees with the disclosures made by the Registrant in response to Item 304(a) of Regulation S-K. A copy of BKD's letter is filed as Exhibit 16.0 and incorporated in this Item 4.01 by reference.
