(3) The Deferred Stock deemed to be held in the bookkeeping account will be payable to the reporting person in shares of HCC Common Stock upon occurrence of certain payment events, including reporting person's termination of service as a director or a change in control of HCC Insurance Holdings, Inc.

(4) This number represents the number of fractional shares of Deferred Stock credited to the reporting person's bookkeeping account as a dividend deemed to be paid.

(5) Acquisition of Deferred Stock based upon dividend reinvestment feature.

(6) This represents the closing price of HCC's Common Stock on Friday, April 16, 2010.
