Unilever NV announces that on 24 August 2007 it purchased 240,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.780 and euro 21.990 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 18,231 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 90,148,285 Unilever NV ordinary shares in treasury, and has 1,624,579,415 Unilever NV ordinary shares in issue (excluding treasury shares).
