Unilever NV announces that on 13 September 2007 it purchased 175,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.410 and euro 22.820 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 7,650 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 93,509,198 Unilever NV ordinary shares in treasury, and has 1,621,218,502 Unilever NV ordinary shares in issue (excluding treasury shares).
