Unilever NV announces that on 6 November 2007 it purchased 158,774 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.390 and euro 23.450 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 1,197,758 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 114,958,432 Unilever NV ordinary shares in treasury and has 1,599,769,268 ordinary NV shares in circulation.
