By letter dated January 2, 2007, the Company reported that on December 29, 2006 holders of Company s Convertible Notes that had already exercised their conversion right exercised their warrant rights. Hence, a reduction of 3,274,437 warrants and an increase of 6,008,138 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 442,734,522 to 448,742,660. The new amount of warrants outstanding is 46,223,874. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6541 for each share face value pesos 1. Therefore US\$ 3,929,925.22 entered into the Company.
