Hill anticipates that its shares of common stock will begin trading on the NYSE on February 22, 2008, under the symbol HIL. Until that time, Hill will continue to trade on the Nasdaq Global Market under the symbol HINT. Hill s Board of Directors has approved the transfer to the NYSE.
