On May 12, 2009, VeriFone Holdings, Inc. VeriFone stockholders are urged to read the Proxy Statement before making any voting decision regarding the proposed Exchange Program, because it contains important information about the proposal to be voted on by stockholders with respect to the proposed Exchange Program.
