This Amendment No. 1 (this Amendment ) to the Schedule 13G originally filed with the Securities and Exchange Commission on May 20, 2011 (the Schedule 13G ) relates to shares of Common Stock, par value \$0.0001 per share (the Common Stock ), of Global Eagle Acquisition Corp., a Delaware corporation (the Issuer ), and is being filed on behalf of (i) Archer Capital Management, L.P. (Archer ), a Delaware limited partnership, as the investment manager to certain private investment funds (the Funds ), (ii) Canton Holdings, L.L.C. 
