***Massachusetts DPU Approves Merger***

***Day One Set for Tuesday, April 10, 2012***

The Massachusetts Department of Public Utilities (MDPU) today approved the merger between Northeast Utilities and NSTAR and the settlement agreements the companies reached with the Massachusetts Department of Energy Resources and the Attorney General, clearing the last regulatory hurdles to the pending merger.

The combination of our companies creates one of the nation's largest utilities, with approximately 3.5 million customers served by six regulated electric and gas utilities in three New England states. The company will be larger, more diverse and better positioned to support continued economic growth in New England and meet customers' future energy needs.

In addition to the MDPU approval, the merger agreement has already received all the necessary regulatory approvals, including the Connecticut Public Utilities Regulatory Authority (PURA), the Federal Energy Regulatory Commission (FERC), the Nuclear Regulatory Commission (NRC), the Securities and Exchange Commission (SEC) and the Federal Communications Commission (FCC).

The companies have set a closing date of Tuesday, April 10, 2012 – the first official day of our newly merged company.
