**Item 2.04. Triggering Events That Accelerate or Increase a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement.**

On February 6, 2013, CDW LLC and CDW Finance Corporation (together, the Issuers ) called for redemption a portion of their outstanding 12.535% Senior Subordinated Exchange Notes due 2017 (the Notes ). The Issuers will redeem \$50.0 million aggregate principal amount of the currently outstanding \$621.5 million aggregate principal amount of Notes. The redemption price of the Notes is 106.268% of the principal amount redeemed, which amount is equal to \$1,062.68 per \$1,000 principal amount, plus accrued and unpaid interest to, but not including, the redemption date, in accordance with the provisions of the indenture governing the Notes. The redemption date will be March 8, 2013.

A copy of the press release announcing the redemption is attached hereto as Exhibit 99.1 and is incorporated by reference herein.
