Item 9.01 Financial Statements and Exhibits.

On January 4, 2013, Colony Financial, Inc. (the **Company**) filed a Current Report on Form 8-K (the **Original 8-K**) to disclose that a wholly owned subsidiary of the Company had funded \$205 million in the aggregate in cash between November 5, 2012 and January 3, 2013, for an increased associate general partnership interest and related partnership units in CSFR Operating Partnership, L.P. (**CSFR**), and such aggregate investment, the **Acquisition**). In the Original 8-K, the Company indicated that, to the extent necessary, the financial statements required by Item 9.01(a) of Form 8-K and the pro forma financial information required by Item 9.01(b) of Form 8-K would be filed by amendment to the Original 8-K within 71 calendar days of the date on which the Original 8-K was required to be filed.

Upon further analysis following completion of the Acquisition, the Company has determined that the Acquisition was not significant under Section 11-01(b) of Regulation S-X and that such financial statements and pro forma financial statements are therefore not required to be filed. Accordingly, the Company hereby amends the Original 8-K filed on January 2, 2013 to eliminate the references to the subsequent filing of financial statements and pro forma financial information relating to the Acquisition.

Therefore, no financial statements and exhibits are required in connection with the Original 8-K.
