**Item 8.01 Other Events.**

On March 6, 2014, the Compensation Committee of the Board of Directors of Equinix, Inc. ( Equinix ) granted long-term incentives to Equinix's executive officers in the form of performance-based restricted stock units ( RSUs ) that are 100% at risk should the performance targets not be attained.

As in prior years, the Compensation Committee used total shareholder return ( TSR ) as a performance metric for 33<sup>1/3</sup>% of such RSUs. Depending upon Equinix's TSR achievement over a two-year period, measured against the Russell 1000 Index, the number of shares earned under the TSR RSUs may range from 0% to 200%. The remaining RSUs may be earned based on achievement of revenue and adjusted EBITDA performance goals for 2014, combined with service-based vesting to the extent the awards are earned.
