**Item 8.01. Other Events.**

On July 8, 2014, Career Education Corporation (the Company ) received notification that the Higher Learning Commission ( HLC ) acted to continue the accreditation of American InterContinental University ( AIU ). The next reaffirmation of accreditation is scheduled for 2023-2024. AIU will have a comprehensive evaluation in 2017-18 and was asked to provide two interim monitoring reports to HLC, which will be completed by the end of January 2015.

AIU issued a press release regarding the reaffirmation of accreditation by HLC on July 17, 2014, a copy of which is attached as Exhibit 99.1, and the information contained therein is incorporated herein by reference.
