<b>Issuer</b>	Canadian Imperial Bank of Commerce ( CIBC )
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately two years
<b>Market Measure</b>	A global equity basket comprised of S&P 500® Index (Bloomberg symbol: SPX ), the MSCI EAFE® Index (Bloomberg symbol: MXEA ) and the MSCI Emerging Markets Index (Bloomberg symbol: MXEF ) (each, a Basket Component ). The S&P 500 Index will be given an initial weight of 45% and each of the MSCI EAFE® Index and the MSCI Emerging Markets Index will be given an initial weight of 27.5%.
<b>Payout Profile at Maturity</b>	2-to-1 upside exposure to increases in the Market Measure, subject to the Capped Value  1-to-1 downside exposure to decreases in the Market Measure beyond a 5.00% decline, with up to 95.00% of your principal at risk
<b>Capped Value</b>	[\$11.90 to \$12.30] per unit, a [19% to 23%] return over the principal amount, to be determined on the pricing date.
<b>Threshold Value</b>	95% of the starting value of the Market Measure
