<b>Market Measure</b>	A global equity basket comprised of the S&P 500® Index (Bloomberg symbol: SPX ), the MSCI EAFE® Index (Bloomberg symbol: MXEA ) and the MSCI Emerging Markets Index (Bloomberg symbol: MXEF ) (each, a Basket Component ). The S&P 500 Index will be given an initial weight of 45% and each of the MSCI EAFE® Index and the MSCI Emerging Markets Index will be given an initial weight of 27.5%.
