On October 18, 2017, Blue Capital Reinsurance Holdings Ltd. issued a press release reporting its initial estimate of losses related to the impact of three major hurricanes which made landfall during period ending September 30, 2017 and two earthquakes in Mexico. On August 25, 2017, Hurricane Harvey made landfall near Corpus Christi, Texas, on September 10, 2017, Hurricane Irma made initial U.S. landfall near the Florida Keys, Florida and on September 20, 2017, Hurricane Maria made landfall in Puerto Rico. Additionally, the Southern Coast of Mexico was impacted by an earthquake on September 8, 2017 while Central Mexico was impacted by an earthquake on September 19, 2017. The press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
