(1) Shares of restricted stock granted pursuant to the Company's 2006 Equity Incentive Plan.

The reported transactions involved an amendment of outstanding options resulting in the deemed cancellation of the existing option and the grant of a replacement option. The number of shares underlying the replacement option has been reduced by 20% and a grant of shares of restricted stock under the 2006 Equity Incentive Plan at the rate of 1 share for each 2 rescinded shares has been made in place thereof. In addition, the replacement options are exercisable with respect to 25% of the options when the Reporting Person completes 12 months of continuous service after 4/3/2006. The options shall become exercisable with respect to an additional 1/48th of the shares subject to the option when the Reporting Person completes each month of continuous service thereafter.
