(1) Incorporated, a registered broker-dealer, sold on behalf of Mr. Robert O. Carr, 22,500, 33,300 and 24,200 shares, respectively, of the Common Stock of Heartland Payment Systems, Inc. (the "Company").

Carr 2001 Charitable Remainder Unitrust; 443,501 shares held by The Robert O. Carr 2000 Irrevocable Trust for Emily Carr and 400,989

(8) shares held by The Robert O. Carr 2000 Irrevocable Trust for Kelly Carr.
