In accordance with the Issuer's equity award program, restricted stock units were forfeited to issuer in satisfaction of tax withholding obligation upon vesting 4,000 restricted stock units on April 8, 2013. The issuer returned such forfeited restricted stock units to the respective stock plan.
- (2) Grant of Restricted Stock. On 4/8/2013, 1,886 shares of Common Stock were withheld by the Corporation to pay taxes due upon vesting of restricted stock, exempt pursuant to Rule 16b-3(e).
- (3) Shares of Common Stock acquired under the Corporation's Stock Incentive Plan, which is a grant of Restricted Stock. The 2,500 shares granted 4/8/2013 vest 25% yearly commencing 4/8/2014.
- (4) This grant has a FMV of \$31.0305.
- (5) Total direct holdings include shares held in the Dividend Reinvestment Plan, shares acquired through the Employee Stock Purchase Plan and shares acquired pursuant to Restricted Stock Awards and Restricted Stock Unit distributions.
