- (1) The employee Restricted Stock units granted 2/4/2016 under the Company's 2016 Long Term Incentive Plan (LTI Plan) will vest in three equal installments beginning on the first anniversary of the grant date.
- (2) Payment of tax liability by withholding securities incident to vesting of restricted stock.
- (3) Represents 25,974 shares of Restricted Stock units (RSUs) and 5,190 shares of Performance shares. As of the transaction date, the Restricted Stock Units have vested as to 13,209 shares.

These performance share awards were issued under the 2016 LTI Plan at 200% of target and have a 3-year vest period and will vest in all or in part upon achievement of performance metrics. Any awards that have not been vested and released at the end of the 3 year period will be cancelled.
