### **Item 3. Sales of Securities and Use of Proceeds.**

During the period covered by this report, RBC Covered Bond Guarantor Limited Partnership and the Bank issued on October 22, 2018, U.S. \$1,700,000,000 3.350% Series CB39 Covered Bonds due October 22, 2021. For this transaction, the joint bookrunners were RBC Capital Markets, LLC, HSBC Securities (USA) Inc., TD Securities (USA) LLC and UBS Securities LLC. The joint lead manager was CIBC World Markets Corp. The co-managers were DBS Bank Ltd. and Standard Chartered Bank.

The net proceeds from the sale of the Series CB39 Covered Bonds were added to the Bank’s general working capital and will be used for general working capital purposes.
