- (1) On a Form 4 filed on April 22, 2008, the reporting person failed to report an additional 62,445 shares of Cheniere Energy, Inc. ("Cheniere") common stock that were sold as a result of a margin call by a broker to whom these shares were pledged. This resulted in a 62,445 share overstatement of the total number of shares beneficially owned by the reporting person in the April 22, 2008 Form 4 as well as in the Form 4 dated September 17, 2008 and, as amended, filed by the reporting person on September 24, 2008. As of the date of this Amendment, the reporting person beneficially owns 271,003 shares of Cheniere common stock, including 10,000 shares owned by the

reporting person's wife and 200,000 shares held through a trust.
