On December 23, 2014, the Company issued 5,000,000 shares of its common stock to reduce an outstanding convertible note payable by \$4,400. On December 23, 2014, the Company issued 7,200,000 shares of its common stock to reduce an outstanding convertible note payable by \$5,616. On December 23, 2014, the Company issued 5,434,782 shares of its common stock to reduce an outstanding convertible note payable by \$5,000. On December 23, 2014, the Company issued 3,541,237 shares of its common stock to reduce an outstanding convertible note payable by \$3,435. On December 29, 2014, the Company issued 3,538,462 shares of its common stock to reduce an outstanding convertible note payable by \$3,220. On December 29, 2014, the Company issued 7,000,000 shares of its common stock to reduce an outstanding convertible note payable by \$5,390. On December 29, 2014, the Company issued 4,533,333 shares of its common stock to reduce an outstanding convertible note payable by \$2,856. These shares were issued pursuant to an exemption from the registration requirements of the Securities Act of 1933, as amended pursuant to Section 4(2) of the Act and/or Rule 506 of Regulation D promulgated thereunder since, among other things, the transactions does not involve a public offering.
