Our net loss during the year ended December 31, 2017 of \$12,301,000 included a goodwill impairment of \$8,449,000. Other non-cash charges in 2017 were \$3,042,000 including \$1,436,000 of depreciation and amortization and \$1,102,000 of amortization of debt issue costs related to our January 2017 Note Purchase Agreement.

Our net loss during the year ended December 31, 2016 was \$3,712,000 including \$1,912,000 of depreciation and amortization and \$479,000 of amortization of debt issue costs related to a prior loan agreement.
