Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and an

investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 11,397,988 shares or 5.185% of the Common Stock outstanding of Chesapeake Energy Corporation ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of Chesapeake Energy Corporation owned by the investment companies at December 31, 2003 included 1,841,557 shares of Common Stock resulting from the assumed conversion of 283,600 shares of CHESAPEAKE \$3.375 CV PFD 144A (6.4935 shares of Common Stock for each share of Convertible Preferred Stock). The number of shares of Common Stock of Chesapeake Energy Corporation owned by the investment companies at December 31, 2003 included 22,078 shares of Common Stock resulting from the assumed conversion of 3,400 shares of CHESAPEAKE 6.75% CV PFD (6.4935 shares of Common Stock for each share of Convertible Preferred Stock). The number of shares of Common Stock of Chesapeake Energy Corporation owned by the investment companies at December 31, 2003 included 1,240,400 shares of Common Stock resulting from the assumed conversion of 255,200 shares of CHESAPEAKE $6\mbox{\%}$ CV PFD $144\mbox{\upshape}$ (4.8605 shares of Common Stock for each share of Convertible Preferred Stock). The number of shares of Common Stock of Chesapeake Energy Corporation owned by the investment companies at December 31, 2003 included 105,473 shares of Common Stock resulting from the assumed conversion of 21,700 shares of CHESAPEAKE 6% CV PFD (4.8605 shares of Common Stock for each share of Convertible Preferred Stock).

Edward C. Johnson 3d, FMR Corp., through its control of Fidelity, and the funds each has sole power to dispose of the 11,397,988 shares owned by the Funds.

Neither FMR Corp. nor Edward C. Johnson 3d, Chairman of FMR Corp., has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Fidelity Management Trust Company, 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 861,575 shares or 0.392% of the Common Stock outstanding of the Company as a result of its serving as investment manager of the institutional account(s). The number of shares of Common Stock of Chesapeake Energy Corporation owned by the institutional account(s) at December 31, 2003 included 108,875 shares of Common Stock resulting from the assumed conversion of 22,400 shares of CHESAPEAKE 6% CV PFD 144A (4.8605 shares of Common Stock for each share of Convertible Preferred Stock).

Edward C. Johnson 3d and FMR Corp., through its control of Fidelity Management Trust Company, each has sole dispositive power over 861,575 shares and sole power to vote or to direct the voting of 861,575 shares of Common

Members of the Edward C. Johnson 3d family are the predominant owners of Class B shares of common stock of FMR Corp., representing approximately 49% of the voting power of FMR Corp. Mr. Johnson 3d owns 12.0% and Abigail Johnson owns 24.5% of the aggregate outstanding voting stock of FMR Corp. Mr. Johnson 3d is Chairman of FMR Corp. and Abigail P. Johnson is a Director of FMR Corp. The Johnson family group and all other Class B shareholders have entered into a shareholders' voting agreement under which all Class B shares will be voted in accordance with the majority vote of Class B shares. Accordingly, through their ownership of voting common stock and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR Corp.
