# Item 1. Description of Registrant's Securities to be Registered.

The securities to be registered hereby are the First Mortgage Bonds, 6.0% Series due May 1, 2051 (the "Bonds") of Entergy Mississippi, Inc. (the "Company"), a Mississippi corporation.
