- (1) Grant of restricted share units which vest in equal portions on February 25, 2011, 2012, 2013, distribution of which is delayed until after retirement. Restricted share units are distributable in Northeast Utilities common shares on a one-for-one basis.

In addition the reporting person directly holds 29,024 stock options to purchase common shares, previously reported on Form 4. Of the total shares owned, the reporting person holds 1,500 shares jointly with his spouse.

Additional phantom shares are issued from the automatic reinvestment of dividend-equivalents exempt from line item reporting under SEC Rule 16a-11.
