- (1) Grant of restricted stock units that cliff vest one year from the date of grant.
 Previously, the Reporting Person filed Forms 4 that incorrectly reported the amount of shares beneficially owned. The Reporting Person's last filed Form 4 on November 4, 2013 reported direct holdings of 206,872 shares and indirect holdings, held in the Mark B. Templeton Revocable Trust, dated June 6, 2004 (the "Trust"), of 58,661 shares for a total of 265,533 shares beneficially owned. This total shares beneficially owned was 20,681 shares less than what was actually owned by the Reporting Person. This discrepancy was primarily due to a transfer of shares from the Trust to Mark B. Templeton, which was reflected in the Reporting Person's indirect holdings, but was not reflected in the Reporting Person's direct holdings.
 - (2) In August 2013, the Trust transferred 58,661 shares to Mark B. Templeton. This transfer did not change the amount of total shares beneficially owned by the Reporting Person.
 - (3) Represents the withholding of shares received upon the vesting of restricted stock units to cover the associated tax obligations.
