Guarantor: JPMorgan Chase & Co.

Minimum Denomination: \$1,000

Basket: The notes are linked to an equally weighted basket consisting of the following:

- 50.00% of the Russell 2000® Index; and
  - 50.00% of the EURO STOXX 50® Index
- (each an “Index” and together, the “Indices”).

Pricing Date: December 27, 2018

Observation Date: December 22, 2023

Maturity Date: December 29, 2023

Participation Rate: At least 118.00%\*

Additional Amount:  $\$1,000 \times \text{Basket Return} \times \text{Participation Rate}$ , provided that the Additional Amount will not be less than zero.

Payment At Maturity: At maturity, you will receive a cash payment, for each \$1,000 note, of \$1,000 plus the Additional Amount, which may be zero.

You are entitled to repayment of principal in full at maturity, subject to the credit risks of JPMorgan Financial and JPMorgan Chase & Co.
