This Amendment No. 4 to Schedule 13G ("Amendment No. 4") amends and supplements the statements on Schedule 13G originally filed on March 3, 1999 and October 20, 1999, as amended by Amendment No. 1 filed on February 14, 2000, Amendment No. 2 filed on February 14, 2001 and Amendment No. 3 filed on February 14, 2002 (the "Schedule 13G"), with respect to the shares of Class A Common Stock, par value \$.01 per share (the "Class A Shares"), of Waddell & Reed Financial, Inc.
