The ownership of 39,449 shares includes the 4,000 share restricted stock award granted on February 6, 2007 from the 2006 Equity Incentive Plan vesting over a five-year period in equal installments beginning on February 6, 2008; and, indirect ownership of 9,199 shares in Ms. Brunner-Salter's Employee Stock Ownership Plan account.

Ms. Brunner-Salter has previously been granted 26,500 options to acquire 26,500 shares of common stock under Provident's 1996 Stock Option Plan, 2003 Stock Option Plan and 2006 Equity Incentive Plan. The options vest ratably over a five-year period and expire in ten years.
