("Celanese") of a new acetic acid manufacturing plant in Nanjing, China and associated industrial gas supply arrangements. The amounts claimed are USD 250 million for compensatory damages and an additional amount in exemplary damages, suggesting a total of not less than USD 960 million. Celanese has not served the complaint on BOC.
